#### FINANCIAL REPORT, Gail Stirr

The balance on hand to begin our branch 2020-21 year is <u>\$7,758.76</u>. This is as of August 1, 2020, with all donations made to AAUW Fund for Excellence (\$500), Friends of Odyssey Family Fund (\$500), and AAUW National Greatest Needs Fund (\$2,000). The \$50 given in prior years to the Wisconsin Women's Network was NOT allocated for this past year, nor budgeted for next year, per discussion at the budget meeting.

#### WOMEN'S HISTORY, Bobbi White & Mary Boyd

Velvalea Phillipps was born in Milwaukee in February 1924. Her life was a series of firsts. She was the first African American woman to graduate from the University of Wisconsin–Madison law school. She was the first to win a seat on Milwaukee's City Council. She was the first to become Secretary of State of Wisconsin (1979–1983). She was the first to become a judge. Most notably, she achieved these milestones at a time when many African Americans were not allowed to exercise their civil rights.

A pioneering civil rights leader, Vel Phillips will be remembered as an unwavering voice for justice here in Wisconsin. After several election defeats, Vel persisted and won a seat on Milwaukee's City Council. Her district was run down with multiple problems in housing, employment opportunities, and other discriminatory acts. Vel proposed her Fair Housing Law in 1962 and participated in nightly marches to highlight these inequities. After six long years with nonviolent marches and protests against discrimination, people started paying more attention to the problems in her district. Finally, in 1968, the Fair Housing Law that Vel had written six years earlier passed the city council.

In addition to her leadership in the Milwaukee civil rights movement, Vel helped other people get elected. The Vel Phillips Foundation still works to help people achieve their dreams.

Reports from:

**Program Committee**, **Jan Robertson:** February program will be on Climate Change. The speaker's portion of the program will be tentatively changed to February 3 in order to collaborate with the League of Women Voter 's program "Highlights of the Governor's Report on Climate Change". Business and social time will remain the fourth Tuesday. Program schedule will be in the Directory with presentations at 7pm followed by business meeting and social time. Meeting will be via Zoom for the present time.

**Kleo Baruth Kritz:** Thanks to Kleo for a donated Zoom account for our Branch. Because of her we are able to have meetings for an undetermined amount of time. Report on Zoom progress. Sixty eight members, sixty are using Zoom. Kleo is setting up an e-mail stream for the Board of Director and one for each of the clubs. The emails will be kept private for AAUW M/M use only.

**Membership: Betty Schmidt and Lynn Christensen**. Lynn Christensen is making name tags for new members; Betty Schmidt has the name tag box and other documents. Discussion of how to make AAUW more visible. Could be on listing of women's organizations in Madison on the internet, Lynn will investigate.

**Finance Officer, Gail Stirr**: Propose budget was reviewed by Board Members prior to the meeting. Major changes are not funding the Women's Network since they have not been very active; and decreasing the donation to the National AAUW from \$2000.00 to \$1000.00 due to the uncertainty of fund raising in the 2020-2021 season. National AAUW ask that funds be directed to greatest needs funds. Jan Robertson made a motion

the budget be presented to membership for approval at the September General meeting. Seconded by Kleo Baruth Kritz, motion carried unanimously.

**Directory, Lynn Celley**: Directory will include General and Board meeting dates as known at present. Directory will be sent to the printers on Monday 8/17/20 and be available for distribution by Friday 8/21/20. New members have been added to the directory. Volunteers for distribution will contact Lynn Celley.

**Hospitality:** Will become active in the future, as in-person meetings become possible.

**Women's History, Mary Boyd and Bobbi White:** Will include a "Women in History" expose in the Scope each month.

**Book Sale, Sharon Knoop and Kleo Kritz:** Members encouraged to collect books and store at their home until the next book sale, hopefully in May 2021.

**Odyssey Meal Project, Ellie Beck**: On hold until meals are possible, will accept donations to the Odyssey Fund. AAUW M/M will give annual donation.

**Silent Auction, Mary Berg**: Scheduled at Maple Bluff for the first Saturday in December but can cancel until one week before if needed, without penalty. Will make final decision at October board meeting. Will look at possibility of an on-line auction.

#### Old Business:

The Monona Community Center will be closed until the first of January and maybe longer depending on the pandemic. Therefore, Book Clubs, Board meetings, General Meetings and General Meeting Presentations will all be on Zoom for the foreseeable future. Movie dates, Bridge Club and La Cuisine are still on hold for the present time. We will decide on Great Decisions as the time gets closer.
