Janesville and Fort Atkinson Branches were able to do a virtual Tech Savvy program for the first time this year. Since it was virtual, it allowed for attendance from other areas of the State. Members of our branch took it upon themselves to contact local school districts of this new opportunity. The Tech Savvy program was also a great success.

The virtual world allowed the Madison/Monona Branch to nominate for the first time a young woman, Eliza Lindley, for the National Leadership NCCWSL conference. She was accepted for a State scholarship and is planning on sharing her learning experiences with our Branch in December. We will look forward to that event.

This year it was the responsibility of District 1 to organize the State Convention. Since the Monona/Madison Branch is in District 1, we were hoping for an in person convention and began work to accomplish that goal. Of course, we had to re-imagine this as the Covid19 virus hit. Instead of canceling another activity, we switched it to a virtual convention. We made it happen with all State Branches participating. It was a huge undertaking and it was appreciated by many. In the process we learned a great deal about how conventions might go forward and will pass this information onto District 5 who will hopefully find it helpful at the 2022 convention.

One of the benefits of the virtual convention is that we now have a State Convention Web Site which we can continue to use in the future.

Last but not least, as we come to the close of the 2020/2021 year we were able to plan an in person June luncheon. We had to adjust the nature of what the luncheon would entail, but the essential part of gathering and sharing a meal together is an important accomplishment.

### SCHOLARSHIPS, Liz Senseman

The recipients of our scholarships and awards to students at UW Madison are:

**Kewiana Pollard** who receives the \$2000.00 Single Parent Scholarship. Kewiana is a single mother growing three African American males. After receiving an associate degree in liberal arts from Madison College she transferred to UW Madison where she is studying communications, and following graduation she plans to attend law school with the intent of practicing civil law. As she states in her thank you note, "I have always had the goal to become a civil lawyer since I was a young child and continuously want to be a motivation to minority communities." She has been involved extensively in community events targeting racial justice issues, and held seats on several of Madison Colleges boards.

Marianna Globacheva who is one of two recipients of the \$1000.00 Outstanding Undergraduate Returning Adult Student Awards. As she describes herself, Marianna is "a 42 year old woman of color, ethnic minority, mother of five, recent immigrant and a college drop-out." She grew up in Moscow and after a somewhat shaky educational experience she became a midwife. However, her ability to assist the most vulnerable women was very restricted, and when the opportunity to immigrate to the U.S. presented itself she did not hesitate. She took all the prerequisites for admission to MATC and entered the nursing program, where she received her RN license. After an initial rejection she gained admission to the UW and is now graduating after continuing her studies in the BSN@Home program. She is getting ready to apply to graduate school. She is all the more remarkable in that her two youngest children, born since her family immigrated, are just two years old and one month old, and meanwhile she has managed to work, go to school and raise her family. She is going to become a maternity care provider the most vulnerable. for Jesus Adrian Garza-Noriega is the second recipient of the OURAS award. Jesus came to the US from Mexico when his parents, who had very little education, decided to leave to seek better opportunities for their 3 children. Unfortunately Jesus' experience with the educational system here was not positive. He states that he was "enrolled in a poorly funded and neglected ESL program that delayed my reading and writing comprehension due to reading a Winnie the Pooh book for eight years straight." He was fortunate to find mentors who were genuinely invested in helping him, and he has resumed his academic career and is now in pursuit of a PhD in counseling. He has been very involved in Latinx programs and services, he is a father of two, and a Marine Corp reservist.

It is interesting to note that all of the candidates for these awards first attended Madison College (MATC). It is also interesting to note that of all the undergraduates on the UW campus, over 30,000, only about 700 are adult students.

- 5. If you need a tax record for the \$59 that are tax deductible, you can copy and paste the information from "Your Contact Information."
- 6. If you have been unsubscribed go to your email and type in <u>connect@aauw.org</u> and request to subscribe again. Just for the record, Joan Schneider, our WI AAUW President, learned she was unsubscribed, too!!!!

This is an important year with changes to AAUW National bylaws to eliminate the degree requirement for membership. Many branches are actively promoting this change. The vote goes from April 7-May 17. ### **GENERAL MEETING MINUTES, April 27, 2021**

Meeting called to order by Donna Anderson Co-President via Zoom at 7:50. Donna welcomed twenty-four members and guest Kristin King.

The minutes of the March 23, 2021, were approved as printed in the *Scope* by Mary Boyd, seconded by Bobbi White.

**Financial Report:** Gail Stirr. The Branch bank account balance at the close of March was \$11,617.76; the current balance on April 27, 2021 is \$12,029.76. Details on April income and expenses will be shared in the May issue of *Scope*.

The Monona/Madison Branch portion of membership renewals from members who renewed online through National AAUW was deposited into our Branch account this month. <u>Membership renewals are due June 1<sup>st</sup></u>.

There was a discussion of how to get a record of the \$59.00 of National AAUW dues that is tax-deductible:

- Gail will contact AAUW National to find out if it is possible for individual members to sign in at AAUW National's website in order to view their own record of dues payments and donations. If this is possible, this record could be printed as a document supporting your tax-deductible payments. The Home page at AAUW National's website does not give any information about individual member accounts/sign-ins.

- Gail can access member dues and donation histories and can print & provide them to you at your request.

- Kleo pointed out that we can substantiate our \$59.00 tax deductible by making a copy of Policy #4 as listed in our Branch Directory for next year.

**Membership: Betty Schmidt & Lynn Christensen.** One new member, Faith Howe, is joining and there is the potential for two more.

**Programs: Kleo Baruth Kritz & Jan Robertson.** The program next month is "Exploring Wisconsin Parks." The Program Committee is continuing to work on finding additional speakers for the coming year.

**Public Policy:** Consuelo Lopez. The State AAUW is offering a Webinar on May 4<sup>th</sup> on Redistricting. Congratulations to Consuelo Lopez on being elected chairperson of the "Community Advisory Committee for the Overture Center." Additional information on this can be found on the Overture website.

**Educational Funds and Scholarship: Liz Senseman**. LaFollette High School has picked their scholarship recipient and Monona Grove will announce shortly. UW-Madison has named the three scholarship recipients. Biographies will be in the May *Scope*.

### Old Business:

**NCCWSL:** Donna Anderson. 38 Wisconsin students received scholarships to attend the leadership conference from State AAUW and various branches. The M/M sponsored candidate for the Leadership Convention has agreed to give a short presentation of her experience at our holiday gathering.

**State Convention News:** Kleo Baruth Kritz. The State AAUW Convention, which was hosted by District 1, was held April 23-24, 2021, virtually. All four of District 1 branches were involved—Beaver Dam, Fort Atkinson, Janesville, and Monona/Madison —with 235 people from all 24 branches attending. A thank you went to all State Convention Committee Members and to Ann Brice, the technology coordinator, for making it all happen. A thank you also went to the significant number of M/M branch members who attended. Kleo complimented Bobbi White for her vibrant introduction to Wisconsin's First Lady. Dido Nash, a former state president, had emailed Kleo: "I have been a member for over 40 years and have attended most conventions and I think that convention was one of our absolute best. Again thank you. Cheers."

**National AAUW Voting:** Kleo Baruth Kritz. National AAUW will be having a vote on new officers and bylaw changes. The major bylaw change is eliminating the degree requirement for membership. Kleo commented that AAUW allows international members, not just Americans; allows associate degrees, not just university degrees; and allows men, not just women. Eleanor Roosevelt, a staunch advocate for women and girls, would not qualify to join AAUW because she only attended a private finishing school from ages 15-17 and never earned a degree. Kleo added that large corporations are uncomfortable making donations to AAUW because we are discriminating. The quorum has already been reached, and you can vote on this policy change until May 17.

**June Luncheon: Gail Stirr.** Our Spring Picnic (in place of a luncheon) will be at Oneida Park Shelter in Monona on Saturday, June 5. Order forms for the boxed lunch menus were in April *Scope* and will again be in the May issue. Submit your lunch choice and payment by May 21, 2021.
