





"Thinking Locally: My Experience as the First African American Mayor in Wisconsin, Plus Public Service to Dane County and the State of Wisconsin

For generations of social activists, Mahatma Gandhi's advice proved helpful: "You must BE the change you want to see in the world." The African American women who raised Frances Huntley-Cooper brought her to civil rights marches in their small







- 1. Frances grew up to become the first elected African American mayor in the state of Wisconsin. Before her election as mayor in 1991, she served as Fitchburg's president of the city council.
- 2. Frances spent 28 years as a social worker in Dane County's Department of Human Services. She received her undergraduate degree in social services at North Carolina A&T State University.



- 3. Frances earned two Master's degrees from the University of Wisconsin-Madison, the first in social work (which landed her in Madison) and the second in public policy and administration from the La Follette School of Public Affairs.
- 4. In 2003, Gov. James Doyle appointed Frances as an administrator in the state's Department of Workforce Development. Committed to national policies in workers compensation, Frances was the first African American woman elected president of the International Association of Industrial Accident Boards and Commissions (IAIABC) in 2009.
- 5. Frances continues her roles at Madison College as a 15-year member of the Board of Trustees.
- 6. Although now retired, Frances is currently changing young lives coordinating Madison's branch of the NAACP's national program, ACT-SO: Afro-Academic, Cultural, Technological and Scientific Olympics. Together, the ACT-SO community teaches high school students the many ways to shine in college, from the sciences to business and the arts. Over 80 Madison students have graduated from ACT-SO since 2015, many earning national gold and silver medals. ACT-SO's 46th national contest will be held July 2023 in Boston.
- 7. Frances Huntley-Cooper is married to Alphonso Cooper (president of Dane Dances, soon planning its 24th season at the Monona Terrace each Friday in August). They have two grown children, Akil Cooper and Hasina Davidson. Frances adores her four beautiful grandchildren, Akil, Kadin, Amira and Zariah.

WOMEN'S HISTORY, Bobbi White & Mary Boyd



Women's History—Lily Ledbetter --Mary Boyd, Bobbi White January 29, 2023 marks the 14th anniversary of the Lily Ledbetter Fair Pay Act of 2009. Therefore, we have chosen Lily Ledbetter to honor this month.

Lily McDaniel Ledbetter was born in 1938, in a house without running water or electricity in Possum Trot, Alabama. She was a capable student but she met and married Charles Ledbetter while still in high school and after becoming a mother found it necessary to seek employment to help support her family. After she worked

in low paying positions for a number of local companies where she performed with competence, she applied for a management level position at the Goodyear Tire Factory in 1979. She applied for management even though the only women she had seen there were in secretarial positions. She was hired as one of the first women at the management level. However, she soon faced numerous instances of discrimination and harassment which added a great deal of stress to the job. Unlike several other women who resigned such positions, she did not give up, pressing on with the belief that eventually things would improve.

Nineteen years later (1998) she received an anonymous tip that she was making thousands of dollars less than men in her same position. She filed and won a sex discrimination suit which awarded her \$3.5 million. Goodyear appealed at the state level and won, negating the award. She then appealed over the course of the next 8 years all the way to the U.S Supreme Court. The Supreme Court ruled against her in 2007 in a 5-4 decision, stating that she needed to report discrimination within 180 days of when the salary decision was made. This is often impossible to do if you are unaware of the discrepancy, as Justice Ruth Bader Ginsburg wrote in her dissent. She encouraged Lily to fight on to change the law.

Working with a legislators and organizations, including **AAUW**, Lily did just that and the **Lily Ledbetter Fair Pay Law of 2009** was passed and signed by President Barack Obama in January of 2009. Sadly, Lily never received a penny from her lawsuits and was only able to pursue those suits with the help of organizations and pro bono support. Her reward was knowing that future women had recourse for such discrimination.
